The large increase in expenditures and revenues between 1997 and 1998 is in large part due to changes in accounting standards. Child benefits, housing benefits, the share of religious organizations in tax revenues and depreciation of tax claims previously subtracted on the revenue side are now shown in gross revenue and expenditures. So are several revenue items collected by government agencies which were previously subtracted from their expenditures. Merchandise exports by region 1970 - 1999


