

Central Bank of Iceland interest rates¹ Effective as of 7 December and 11 December 2011

With reference to Article 10 of the Act on the Central Bank of Iceland, no. 36/2001, with subsequent amendments, the Bank has decided that interest rates on Central Bank facilities for financial undertakings shall be as follows. Interest rates according to Items I.1, I.2, and II.1 take effect on 7 December, and interest rates according to Items II.2 and II.3 take effect on 11 December.

Other interest rates are decided by the Governors at any given time. As soon as the interest rates according to this announcement take effect, the Central Bank of Iceland interest rates according to the announcement of 2 November 2011 shall cease to apply.
